

2012 CULLEN WINES DIANA MADELINE CABERNET MERLOT

Review Summary



98 pts/Top 100 Wines of 2014 “A 76/17/7% blend of Cabernet Sauvignon, Merlot and Cabernet Franc aged for 19 months in French barriques (38% new). The palate has astonishing power and length given its alcohol, reflecting the years during which the vineyard has been managed biodynamically, the soil filled with life and beneficial micro-organisms that are indisputably having a positive impact on the vines. You might well be looking at a wine from Bordeaux's Left Bank, coiled up like a spring, but perfectly balanced, the finish almost painfully long.”

94 pts “Inky ruby. Mineral- and smoke-laced blackcurrant and cherry aromas are complemented by deeper notes of licorice and mocha. Sappy, seamless and focused, offering sweet black and blue fruit flavors and a hint of anise. This rich yet animated blend finishes with excellent clarity and length and silky tannins that add shape. Extended aeration brought out a lively mineral character and a sexy lavender pastille quality along with added weight.”

93 pts “The biodynamic calendar aligned with the ripening of Cullen’s Diana Madeline Cabernet Sauvignon block in 2012; Vanya Cullen reports that all the grapes were harvested from the 7th to the 9th of March, three fruit days under a full moon. That block makes up 76 percent of the blend, the balance equal parts Merlot and Cabernet Franc. The wine’s plump fruit takes a claret-like shape, Twiggy-thin but amply filling out the structure with fresh black currant flavor. There’s plenty of oak tannin to capture the fruit intensity, framing herbal and cassis scents with resinous wood notes, suggesting long development ahead.”
